ASSIGNMENT



The ASSIGNORS warrant and represent to the ASSIGNEE that they are the joint owners of the Trade Marks and have the right and power to enter into and fully perform their obligations under this Deed, and if called upon to do so they will execute all such documents and perform all such acts as may be necessary to complete or record the ASSIGNEE'S title to the Trade Marks.
- 4. This Deed is governed by the laws of New South Wales. The parties submit to the jurisdiction of courts exercising jurisdiction there.
